President's Message

Today, we are commemorating AYSP's 34th year of operation and we appreciate those who are able to join us as we celebrate

This year, due to the COVID-19 Pandemic, we are not able to celebrate with service partners, opting, instead, for a virtual gathering of our members. Regardless, we are still proud to come together to acknowledge our accomplishments over the past year.

AYSP's activities during 2019/2020 aligned with our Strategic Plan directions, with activities to support services, human resources, operations and partnerships.

The Annual Report provides recognition of the overall performance of AYSP and the number of young people we have served, often with their families, through our various programs. These programs are run by AYSP staff members who dedicate their time and energy to creating meaningful relationships with those who seek our support. In an ongoing effort to maximize program effectiveness, AYSP sought to incorporate additional evidence-based practise into our work. To that end, the Triple P program was introduced this past year with training and implementation occurring into 2020/2021. AYSP continued to work with partners in education, child welfare, health and developmental services and with our core service provider partners and lead agency to support our children's mental health services. Additionally, we continue to work alongside Police, Probation and Crowns to support our youth justice services. Unfortunately, after 30 years, we ceased to operate our Court Intake services when the program responsibilities were reassigned to Probation staff.

Over this past year, we bid farewell to some staff members and welcomed new faces to our team, both in the front lines and in leadership roles. Prevalently, AYSP staff actively seek opportunities to develop their skills and abilities on an ongoing basis. Staff members have been trained to provide trauma-informed support to young people and families and have worked hard this year to integrate this knowledge and understanding throughout our services.

AYSP also launched a new website and created a presence on social media to highlight our work, recognize the work of others and invite community members to seek our support.

2019/2020 was the first full year of children's mental health operations under the Ministry of Health and, moving forward, our Youth Justice Committee programming will now be supported through the Ministry of Children, Community and Social Services as this portion of our work shifts under their jurisdiction from the Ministry of the Attorney General. We continue to work with the United Way of Greater Toronto and welcome the opportunity for ongoing learning and development.

We acknowledge and appreciate our existing working partnership in the community. The relationships with our funders is positive and supports our ongoing work within our community. AYSP continues to be a part of provincial associations and seeks opportunities to build collaborative partnerships in the communities in which we work; allowing us to increase our understanding and awareness of issues and our role in finding and supporting solutions.

In March of this fiscal year, the global pandemic forced AYSP to shift, quickly, to virtual services. Although, not without its issues, this transition was done quickly and efficiently by everyone and allowed service to our community to continue effectively. Through this, the dedication, flexibility and commitment of our staff have demonstrated that we can rise to any challenge on behalf of young people and their families and realize success; you continue to make a difference in people's lives. I want to express my thanks, to each of you, for this.

The year ahead is sure to challenge us, it will also offer us opportunity. It will be important to build on AYSP's collective strengths and to persevere, so our next steps forward contribute positively to the needs within our community.





AYSP 2019-2020 Revenue




AYSP 2019-2020 Expenses

AYSP Volunteers

AYSP offers a rewarding volunteer program to support children, youth and their families receiving services at AYSP. Our volunteers are an important part of the day to day lives of the people we serve. AYSP's volunteer pool includes diverse individuals who bring a wide array of knowledge, experience and talents to our agency.

All AYSP volunteers undergo a mandatory five-week training and orientation program which prepares them and ensures they are well-equipped to participate in a variety of volunteer opportunities. This past year, in addition to the mandatory



volunteer policies and procedural training, some additional topics covered in training included anti-racist anti-oppressive framework, building engagement skills and group facilitation skills.

AYSP volunteers are matched with opportunities which allow them to utilize their skills and gain experience. Volunteers contributed to several programs this past year. Some of these included our Mentorship Program, Tutoring Program, Life Skills Program Co-Facilitator, One-to-One Program Facilitator and AYSP's Youth Justice Committees.

Volunteers meet AYSP clients and Probation clients in the community to facilitate one-to-one sessions, including mentorship and tutoring. Volunteers work collaboratively with the referring worker to ensure identified goals are being met.

AYSP's volunteer pool includes diverse individuals who bring a wide array of knowledge, experience and talents to our agency.

Additionally, AYSP volunteers also facilitate a variety of in-house programs to clients, including Anger Awareness, Social Media Awareness and Responsibility Training (SMART), Life Skills and Choices for Healthy Relationships. Volunteers encourage client participation through various modes including discussion, reflection, role playing and individual homework.

The Youth Justice Committee Program gives AYSP Volunteers the opportunity to facilitate restorative justice circles with other volunteer community members. During the circles, persons harmed, the young person, their supports and the community members are all able to offer their perspective on what happened, how it caused harmed and what can be done to repair the harm.

AYSP offers volunteers training and workshops to advance their knowledge on client demographics and recurring trends in our community. They are provided with opportunities to further develop their skills when working with clients. As well, AYSP hosts volunteer appreciation events throughout the year to recognize their efforts and successes. This year, AYSP volunteers were presented with several opportunities

for professional growth and development. Some of these opportunities included Safe Talk, Human Trafficking Workshops, and a Community Resource Event. Additionally, AYSP hosted volunteer social events to foster team building and provide program updates. AYSP was also able to recognize and thank volunteers during an awards evening in November.

AYSP volunteers are compassionate, dedicated individuals who commit their time to the clients we serve. AYSP is thankful for all the contributions volunteers made this past year!
